Consent Form Release From Liability & Indemnity Agreement

I/We, the undersigned parent(s) or guardian(s) of _____, a minor, do hereby CONSENT to his/her transportation to or during a school-sanctioned event within the Triton Regional School District by a voluntary adult driver in a private vehicle.

I/We RELEASE and discharge the Triton Regional School District and its departments, officers, employees, and agents (hereinafter collectively referred to as "School District"), from any and all claims, damages. Losses or expenses of whatever kind or nature which I/we may have or acquire as the parent(s) or guardian(s) of said minor arising out of or resulting, directly or indirectly, from said minor's participation in the event. I/we also RELEASE and discharge the School District from all claims, damages, losses or expenses of whatever kind or nature which said minor may have or acquire arising out of or resulting from, directly or indirectly, his/her participation in the event. I/we furthermore agree to defend and INDEMNIFY the School District against any claim, damage, loss or expense of whatever kind or nature that the School District may have to pay that rises from said minor's intentional, grossly negligent, or reckless acts or omissions while participating in the event.

I/We hereby authorize the School District's employee(s) or agent(s) who is supervising said minor to act on our behalf in authorizing and consenting to emergency medical care for said minor if he/she becomes ill or is injured while participating in the event. This Authorization and Consent may be presented to the appropriate emergency medical staff at such time as emergency medical care is required. I/we hereby RELEASE and discharge the School District from any and all claims of any nature whatsoever, which may arise out of the decision to provide emergency medical care.
